Details of Proposed Amendment: To facilitate the creation of five new residential lots along an extension of Burgess Street, Burgessville and to Rezone the lots to be subdivided from 'Institutional Zone (I)' to 'Residential Type 1 Zone (R1)' to facilitate the proposed subdivision and permit the construction of one single detached dwelling per lot.

Mr. Nathan Kok, agent was in attendance representing the application.

Ms. St. Clair outlined the application as contained within Report CP 2022-243. She advised that Draft Plan of Subdivision will facilitate creation of five new residential lots to be accessed via an extension of Burgess Street and retention of one lot that will remain the Netherlands First Reformed Church. The proposal which will include private wells and septic systems, will allow for infilling and rounding out of the existing settlement area and assist in meeting local housing needs. Studies provided indicate possible nitrate impact which will require an enhanced tertiary system and staff recommend entering into an agreement regarding these systems. Ms. St. Clair further advised that the subject lands are approximately 14 acres in size, contain an existing church, parsonage and parking. A Site Plan Application is currently under review to facilitate an addition to the east side of the existing church.

There was Council discussion with respect to: tertiary septic systems, storm water review, the culde-sac turning circle and snow removal.

There was no one in attendance that wished to speak in support of or against the application

John Rettie

Re: Norwich Optimist Tractor Pull

Ms. Jo-Ann Hanson spoke on behalf of the Norwich Optimist Club. She commented that in September the Club celebrated their 30th Anniversary. Ms. Hanson advised that all funds raised go back into the community and listed some of the projects and events that have taken place, such as: the Norwich Splash Pad, soccer park, bike rodeos and fishing derby. The Clubs major fundraiser is the Tractor Pull held on the Rettie Farm annually. This event is a lesson in inclusivity and appeals to everyone, which requires hundreds of volunteers working together. She provided some letters of support from five neighbouring property owners, the Norwich Skating Club and Norwich Legion.

Faye Berrigan

Re: Water Drainage Issues

Mr., Vic Whitcroft was in attendance representing Ms. Berrigan. He explained that she has a problem with water pooling on her property and requested that someone inspect the issue to determine what steps need to take place to alleviate the issue. He commented that a recently built

residence in the area has caused the issue to worsen and that every time a residence has been built over the years, the situation has gotten worse.

Jacob Dey

Re: Placement of Pride Banners

Mr. Dey advised that he was greatly grieved to learn the progress banners were hung and when he attempted to meet with Council, could not, due to quorum and timing restrictions. He referred to meeting with the Mayor to discuss his ethics and requesting the banners be removed by Sunday, making it clear they would be removed if they still hung there by Sunday. Mr. Dey made reference to the Canadian Charter of Rights and Freedoms, commenting that freedom is based on mutual respect.

Mr. Dey made reference to verses from the King James version of the Bible, referencing it as an operating manual for mankind, advising that there are consequences for going against God's word. Mr. Dey referenced the transition from gay flag to pride, then all inclusive and now progressive, commenting it comes with nice speeches and explanation, however when we hang up this flag we are also supporting things like: drag queen story time in the library, the radical sex bill, children being told they can select their gender at the age of six. He made reference to Rainbow Certification for LGBTQ friendly business and commented that not only is this driving a chasm in our families, it also now affects the workplace. Mr. Dey questioned where this group falls into the definition of groups included in the Charter of Rights and Freedoms and compared it to social movements such as Black Lives Matter and Nazi Germany. He expressed concern with the hanging of the Progress Banners causing division in the community where previously there was none.

7.4 Alisha Stubbs

Re: Diversity, Equity, Inclusion and Accessibility

Ms. Stubbs advised that she is referencing research, definitions and facts, due to concerns brought forth due to criminality and some feeling unsafe within the community after recent events. She made reference to information as outlined by: Statistics Canada, a Crowdsource Survey, a recent study by Adams (2021), Ontario Human Rights Commission and information from the Centre for Gender, Diversity and Inclusion. She expressed concerns with the vandalism and theft of the pride banners, referencing Ontario Human Rights Commission statement that 'when beliefs infringe on community safety and human rights, they are no longer simply beliefs'. Ms. Stubbs commented that the progress flag does not need to represent the entire community because it is meant to open the community for marginalized groups to feel safe. She referenced statistics with respect to victimization, inappropriate behaviours, hate crimes, violent crimes and mental health.

Ms. Stubbs made reference to the Community Safety and Well-Being Plan, commenting that inclusivity is being mandated and expected at all levels, that it is not belief based, it is human rights based, providing safety and support for marginalized community members.
