



THE CORPORATION OF THE TOWNSHIP OF NORWICH

BY-LAW NUMBER 10-2021

BEING A BY-LAW TO AMEND BY-LAW 38-2020 TO PROVIDE FOR THE ADOPTION OF USER FEE RATES FOR THE PERIOD OF JULY 1, 2020 TO JUNE 30, 2024 FOR THE TOWNSHIP OF NORWICH.

WHEREAS The Municipal Act 2001, S.O. 2001, c. 25, as amended, provides that a municipality may pass by-laws imposing fees and/or charges on any class or persons;

AND WHEREAS the Council of the Corporation of the Township of Norwich enacted By-law No. 38-2020 on July 14, 2020 to Provide for the Adoption of User Fee Rates for the Township of Norwich;

AND WHEREAS the Council of the Corporation of the Township of Norwich deems it advisable to amend By-law No. 38-2020;

NOW THEREFORE the Council of the Corporation of the Township of Norwich hereby enacts as follows:
