The August 19th meeting of the Township of Norwich Police Services Board was held via teleconference, commencing at 5:00 p.m. with Vice Chair Lori Vermeersch presiding.

Others in Attendance: Inspector Tony Hymers, Paul Groeneveld, Director of Fire and Protective Services, and Kimberley Armstrong, Deputy Clerk.

There was discussion about electronic meetings and Inspector Hymers advised that the Ontario Association of Chiefs of Police are also meeting virtually.

6. REPORTS and GENERAL BUSINESS

After Board discussion, Ms. Vermeersch requested that Inspector Hymers present highlights of the first four reports and present the June and July reports in detail.

6.1 Police Service Board Report – February 2020

Inspector Hymers provided highlights of the February report, commenting on: the 19 speeding charges and locations; and an anticipated decrease in calls due to changes in handling of 911 hang-ups and false alarms.

6.2 Police Service Board Report – March 2020

Inspector Hymers provided highlights of the March report, advising that there were 124.25 hours of cruiser time and 11 hours of foot patrol. He advised that he participated in the Polar Plunge for Special Olympics Ontario. Inspector Hymers commented that the first meeting regarding COVID-19 was held on Friday March 13th, at which time the impact was unknown. He commented that protocols and getting supplies of proper PPE were high priority. He further commented that he held a monthly conference call with all the local PSB Chairs when the regular PSB meetings were cancelled due to COVID.

6.3 Police Service Board Report – April 2020

Inspector Hymers provided highlights of the April report, advising that there was a decrease in property related crimes. In response to questions related to reduced foot patrol hours, Inspector Hymers advised that it was possibly related to the pandemic.

6.4 Police Service Board Report – May 2020

Inspector Hymers provided highlights of the May report, commenting on media releases for: prohibited weapons seized with link to the Outlaw Motorcycle Gang, a single vehicle collision, Canada Road Safety Week, ongoing trespassing issues and commercial vehicle inspections. He further commented that traffic volume was considerably down during April and there were 45 speeding charges.

6.5 Police Service Board Report – June 2020

Inspector Hymers presented the June report, advising that there were 178 cruiser patrol hours, 3 hours of motorcycle patrol hours and 4.5-foot patrol hours. The targeted releases for June focused on: stunt driving, reporting crimes online, drug impaired driver, Elder Abuse Awareness Day, lifesaving equipment and vehicle stolen with keys inside. Other items of note included: Canada Day enforcement, the 'Lock it or Lose it' program being

shut down during COVID since it is on a volunteer basis and an overview of other charges laid. There were 45 PON charges, of which, 31 were for speeding.

In response to Board questions, Inspector Hymers advised that there were Black Lives Matter protests in June in Tillsonburg and Ingersoll. No charges were laid.

6.6 Police Service Board Report - July 2020

Inspector Hymers provided an overview of the July Report and statistics, advising that there were 165.25 hours of cruiser patrol and 4 hours of foot patrol in the month. Inspector Hymers noted the targeted media releases for: the new online process to obtain criminal reference checks, impaired driving, dealing with wild animals, report of a wandering child and lack of compliance with the 2003 Move Over Law.

In response to questions, he advised that there is currently only one motorcycle officer trained because COVID has interfered with additional training. Inspector Hymers provided an overview of the various charges, highlighting the 70 speeding charges, commenting on the majority being on Main Street, Highway 59, Cornell Road and Oxford Road 13. Provincial Courts have been delayed due to COVID-19 and are now starting to get back on track.

There was Board discussion regarding; the correlation between the increase in traffic through the staged openings and speeding charges and changes to the way the COM Centre deals with 911 calls.

Vice Chair Vermeersch expressed gratitude to the OPP on behalf of the Police Service Board for all their work over the last few months during the pandemic. She also expressed concerns that employees are getting worn down and consideration needs to be given to mental health.

Notes to Annual Billing Statement

- 1) Municipal Base Services and Calls for Service Costs The costs allocated to municipalities are determined based on the costs assigned to detachment staff performing municipal policing activities across the province. A statistical analysis of activity in detachments is used to determine the municipal policing workload allocation of all detachment-based staff as well as the allocation of the municipal workload between base services and calls for service activity. For 2021 billing purposes the allocation of the municipal workload in detachments has been calculated to be 53.1 % Base Services and 46.9 % Calls for Service. The total 2021 Base Services and Calls for Service cost calculation is detailed on the Base Services and Calls for Service Cost Summary included in the municipal billing package.
- 2) Base Services The cost to each municipality is determined by the number of properties in the municipality and the standard province-wide average cost per property of \$177.48 estimated for 2021. The number of municipal properties is determined based on MPAC data. The calculation of the standard province-wide base cost per property is detailed on Base Services and Calls for Service Cost Summary included in the municipal billing package.
- 3) Calls for Service The municipality's Calls for Service cost is a proportionate share of the total cost of municipal calls for service costs calculated for the province. A municipality's proportionate share of the costs is based on weighted time standards applied to the historical calls for service. The municipality's total weighted time is calculated as a percentage of the total of all municipalities.
- 4) Overtime Municipalities are billed for overtime resulting from occurrences in their geographic area and a portion of overtime that is not linked specifically to a municipality, such as training. Municipalities are not charged for overtime identified as a provincial responsibility. The overtime activity for the calendar years 2016, 2017, 2018 and 2019 has been analyzed and averaged to estimate the 2021 costs. The costs incorporate the 2021 salary rates and a discount to reflect overtime paid as time in lieu. The overtime costs incurred in servicing detachments for shift shortages have been allocated on a per property basis based on straight time. Please be advised that these costs will be reconciled to actual 2021 hours and salary rates and included in the 2023 Annual Billing Statement.
- 5) Court Security and Prisoner Transportation (CSPT) Municipalities with court security responsibilities in local courthouses are billed court security costs based on the cost of the staff required to provide designated court security activities. 2021 costs have been based on 2019 security activity. Prisoner transportation costs are charged to all municipalities based on the standard province-wide per property cost. These costs will be reconciled to the actual cost of service required in 2021.
 - There was no information available about the status of 2021 Court Security Prisoner Transportation Grant Program at the time of the Annual Billing Statement preparation.
- 6) Year-end Adjustment The 2019 adjustment accounts for the difference between the amount billed based on the estimated cost in the Annual Billing Statement and the reconciled cost in the Year-end Summary. The most significant year-end adjustments are resulting from the cost of actual versus estimated municipal requirements for overtime, contract enhancements and court security.

Notes:

Total Base Services and Calls for Service Costs are based on the cost of salary, benefit, support and other direct operating expenses for staff providing policing services to municipalities. Staff is measured in full-time equivalent (FTE) units and the costs per FTE are described in the notes below.

- 1) Full-time equivalents (FTEs) are based on average municipal detachment staffing levels for the years 2016 through 2019. Contract enhancements, court security, prisoner transportation and cleaning staff are excluded.
 - The equivalent of 87.76 FTEs with a cost of \$14,900,558 has been excluded from municipal costs to reflect the average municipal detachment FTEs required for provincially-mandated responsibilities eligible for Provincial Service Usage credit.
 - Salary rates are based on weighted average rates for municipal detachment staff by rank, level and classification. The 2021 salaries incorporate the 2021 general salary rate increases set in the 2019 to 2022 OPPA Uniform and Civilian Collective Agreements, (uniform staff 1.00% January 1 and 0.97% July 1, civilian staff (one 2021 increase) 1.0% January 1). The benefit rates are based on the most recent rates set by the Treasury Board Secretariat, (2020-21). Statutory Holiday Payouts, Shift Premiums, and Benefit costs are subject to reconciliation.
 - FTEs have been apportioned between Base Services and Calls for Service costs based on the current ratio, 53.1% Base Services: 46.9% Calls for Service.
- 2) Support Staff Costs and Other Direct Operating Expenses for uniform FTEs are calculated on a per FTE basis as per rates set in the 2020 Municipal Policing Cost-Recovery Formula.

I am pleased to share with you that the Ontario government has appointed Devon Clunis as the province's first Inspector General of Policing. In this new role, Mr. Clunis will provide oversight of policing in Ontario. He will also be responsible to set up an Inspectorate of Policing which will work with the government and its partners to develop regulations under the Community Safety and Policing Act, 2019 (CSPA). Mr. Clunis's appointment is effective October 13, 2020.

Devon Clunis joined the Winnipeg Police Service in 1987 and served in all areas of the service over the course of his career before being named to the role of Chief in 2012. As Chief of Police, Mr. Clunis led a transformational and cultural shift within the service that successfully modernized its model of policing from reactive and crime focused to a proactive community health and well-being model.

The inspectorate will operate at arms-length from government to provide independent policing oversight and ensure effective policing services are provided to every community in Ontario. The inspectorate will:

- Monitor and conduct inspections of police services to ensure compliance with the CSPA and its regulations once the CSPA is in force.
- Monitor and conduct inspections of police service boards to prevent police misconduct and impose measures where necessary.
- Investigate policing complaints related to the provision of adequate and effective policing services.
