Details of Proposed Amendment: to rezone the lot to be retained from Consent Application B 22-13-3 from 'Limited Agricultural Zone (A1)' to 'Rural Residential Zone (RR)' and to rezone the lot to be severed from 'Limited Agricultural Zone (A1)' to 'General Agricultural Zone (A2)' to facilitate the proposed farm consolidation and to recognize the new use of the lot to be retained as non-farm rural residential and the rezoning of the lot to be severed will ensure that the zoning coincides with the lot to be enlarged.

Mr. Wilson, owner, was in attendance.

Ms. St. Clair outlined the application as contained within Report CP 2023-6. She advised that the rezone will facilitate a farm consolidation which proposes to create a non farm rural residential lot and add lands to the farmlands to the immediate south. The rezone will recognize the retained rural residential 2-acre lot and also ensure consistent zoning of the farmlands which are being transferred. The residential lot contains a historically designated structure for which Council recently approved a by-law amendment to remove the designation from the entire property and designate the structure only. She also advised that no comments or concerns received as a result of circulation.

Gord Hough, Director Community Planning and Heather St. Clair, Senior Planner Re: Council Orientation – Community Planning

Mr. Kruger advised that although this item appears under Delegations on the Agenda, it is a Council requested Orientation so the time limit will not apply to this presentation.

Mr. Hough, Director of Community Planning, provided an overview of the Planning function and services in Oxford County, referencing the single County-wide Official Plan and individual municipal Zoning By-laws and the provision of policy and development planners.

Ms. St. Clair, Senior Planner, provided background on the planning process, including: land use planning, establishing goals, attempting to avoid conflicts between different land uses, creating liveable communities and the process for approvals at the County or Township level. She explained that there is a planner assigned to each municipality and that they provide advice and administrative services. Ms. St. Clair provided an overview of the Planning hierarchy system advising that key policy direction comes from the Planning Act, the Provincial Policy Statement, Official Plan and Zoning By-laws.

There was Council discussion with respect to: how often the zoning by-law is updated, Official Plan review every five years and changes are now required due to legislative changes and the Ontario Land Tribunal.
