Details of Proposed Amendment: To rezone the subject lands from 'Limited Agricultural Zone (A1)' to 'Special Limited Agricultural Zone (A1-sp)' to facilitate development of an addition residential dwelling unit (ARU) in an existing detached accessory structure.

Mr. Ali Zulfiqar, agent for the applicant, was in attendance representing the application.

Ms. Amy Hartley, Planner, outlined the application as per Report CP 2023-400 to allow for the establishment of an additional residential unit (ARU) in a portion of an existing accessory building that was previously established as a dwelling unit without benefit of a permit. Since the accessory building was previously used as a dwelling unit there is an existing separate septic system which would serve the proposed ARU.

Ms. Hartley noted that since the construction of both the dwelling unit inside the farm building and the septic system were undertaken without permits, a change of use permit, appropriate building permits and compensating construction will need to be completed prior to occupancy of the ARU.

In response to questions from Council, Ms. Hartley advised that the proposed plan for the ARU is to completely renovate the dwelling and ensure everything is up to code. Ms. Hartley further noted that ARUs are a good option for housing and advised of an upcoming amendment to the zoning by-law to allow for additional residential units.

In response to questions from Council Mr. Zulfiqar advised that the ARU was already built when the current owners acquired the property in 2021 and they assumed the tenant that was there. He advised the owners were not aware of the zoning issues at the time of purchase and they plan to have the ARU available for family to live in.

Henry Centen, R.J. Burnside Re: 2023 Roads Needs Study

Mr. Henry Centen, Senior Transportation Engineer, R.J. Burnside, was in attendance to provide an overview of the 2023 Roads Needs Study. He advised that this is in draft form and would like Council's input today. He commented that the Study is divided into hard top roads and gravels roads in the second phase to take place in the spring. Mr. Centen explained that they are evaluating the road surface explaining it is more conducive to do life cycle maintenance than complete reconstruction.

In response to questions from Council, Mr. Centen advised that: the \$3,000,000 for road maintenance was only to maintain the current network condition, road surface composition types vary by municipality and micro-surfacing only reseals the surface deficiencies which stops cracking from causing issues prematurely and should be applied at the 7-year mark.

In response to questions from Council, staff advised that the Airport Road project discussed at the recent Capital Budget meeting was not a resurfacing, but an overlay since the surface layer was never applied. Additionally, that the work on New Road will consist of griding up the tar and chip surface and returning it to tar and chip.

Councillor Couwenberg requested Council members support a 2% across the board reduction to the Operating Budget to help residents. There was Council discussion regarding implications of an overall 2% reduction.

In response to questions from Council, staff advised that municipal corporations do not operate for profit and services offered by municipalities are for the benefit of residents. Additionally, most services cannot cease to operate if a budget runs out which would result in overages being covered by reserves. Since reserves are allocated for specific uses, they would then need to be replenished the following year. Generally, a reduction to the operating budget would result in a reduction in service.

Staff further advised that most operating budget items are uncontrollable costs either by law, contract or established existing service levels (eg. OPP contract, salaries, road maintenance) leaving only about \$300,000 in unfixed costs in the operating budget, which would require approximately \$140,000 in reductions to achieve a 2% overall target.

There was further Council discussion regarding opportunities to save costs associated with purchasing and that Council can explore changes to the budget during the budget process.
