4 Swimming Pool Fence Permit

POOL ENCLOSURE MUST CONFORM TO TOWNSHIP BY-LAW 10-98, INCLUDING BUT NOT LIMITED TO:

Every fence shall be not less than forty-eight (48) inches in height and bottom of fence must not be more than two (2) inches above grade.

Every fence shall be constructed so that it cannot be used in a similar manner as a ladder.

All gates or doors (excluding door to dwelling house) shall be equipped with a self-closing device and a self-latching device on the poolside at top of the gate to the intent that all gates or doors will remain securely closed when not in actual use.

Every fence enclosing a pool shall be located not closer than 4' to the swimming pool.

i) 2" in any direction if constructed of chain link material.

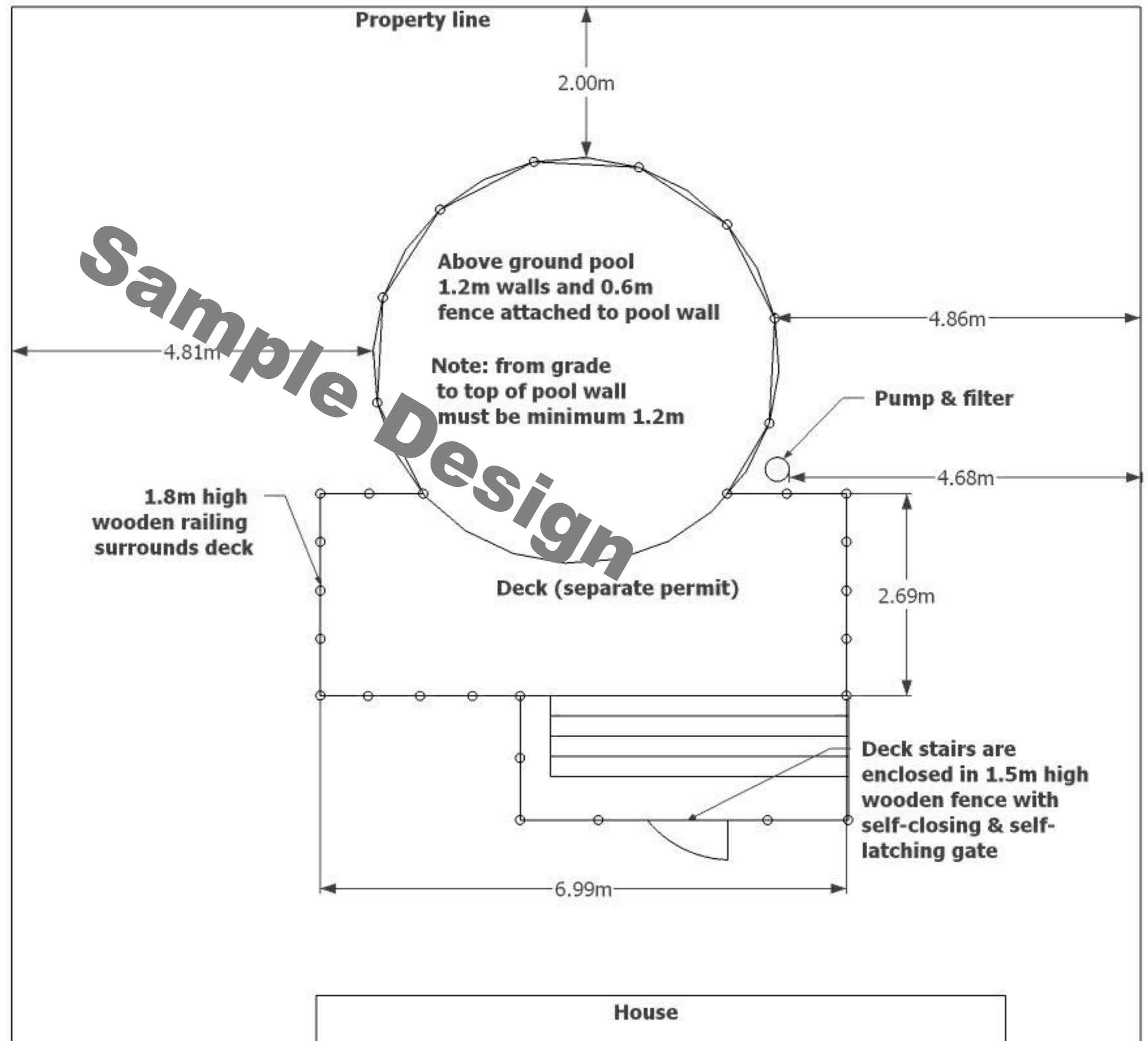
ii) 3 1/2" horizontal direction if constructed of material other than chain link fencing.

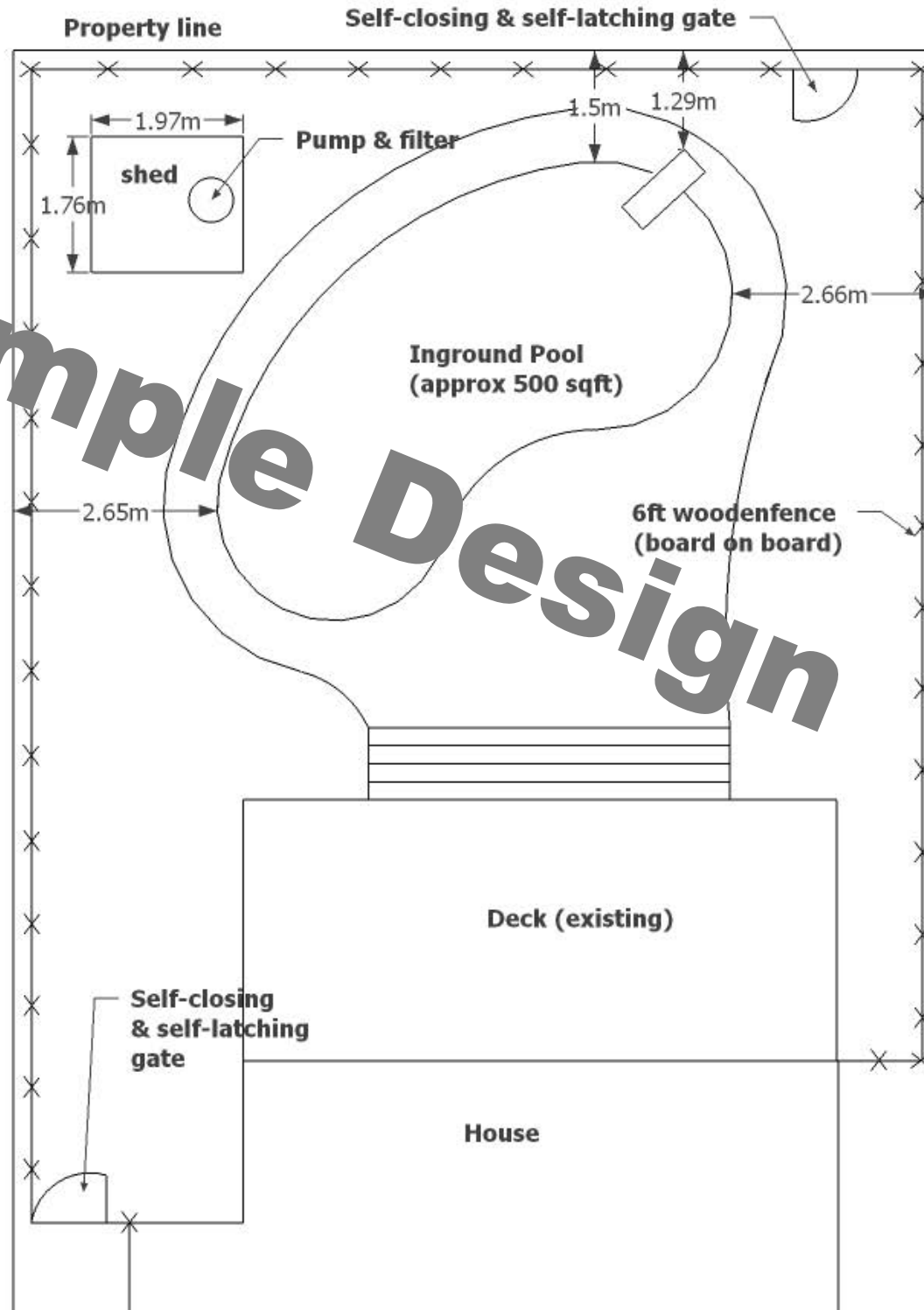
