Details of Proposed Amendment: To Rezone three lots to be severed from recently approved consent applications from 'Special Development Zone (D-11)' to 'Residential Type 1 Zone (R1)' to facilitate the creation of three new residential building lots in the Village of Otterville, and: amend the existing site specific 'Special General Agricultural Zone (A2-39)' that applies to the retained lands to recognize the amended lot area that will result from the consent applications.

Mr. Rick DeWachter was in attendance representing the application.

Ms. St. Clair outlined the application as contained within Report CP 2022-438. She advised that this application proposes to rezone three new residential building lots which have received conditional approval for severance. The rezone would also recognize the revised lot area for the retained lands which will continue to be used for agricultural purposes. It is proposed that each new lot will contain a single detached dwelling and a private septic system. The lots and will be accessed by way of a shared driveway arrangement which will be subject to an easement.

In response to Council questions, staff advised that the most southerly lot has an access easement over the other lots and that a road widening has been taken for future use and can be used if a retaining wall is necessary in the future.

Mr. DeWachter commented that the shared driveway will enter on lot one and follow along the road which should eliminate the need for a future retaining wall.

There was no one in attendance that wished to speak in support of or against the application.

residential dwelling unit with a reduction to the Minimum Distance Separation 1 setback of 285m in place of the required 560m from the barn to the southwest, and: 530m in place of the required 565m from the barn to the north.

Ms. Ann Couwenberg was in attendance representing the application.

Ms. St. Clair outlined the application as contained within Report CP 2022-433. She advised that the applicants propose to construct an additional residential dwelling unit, either single detached or within another structure to be located on the west side of the existing dwelling. The proposed location is non compliant with the hog barn to the southwest and also the hog barn to the north which is owned by the applicant. The applicants have indicated that the requested location is best operationally for farm, including a washroom and hand washing facilities near the poultry barn as required for farm biosecurity reasons. It is also preferred from a servicing perspective and the area is not ideal for crop production being difficult for maneuvering farm equipment.

Ms. St. Clair advised that the proposal meets policy for a secondary dwelling, utilizing the existing lane and being within the building cluster, however, is non compliant with MDS 1 requirements, therefore staff are recommending that the dwelling be located to the east of the existing dwelling.

Ms. Couwenberg commented that MDS requirements are mainly for odour and as farmers and family dwelling in the second residence, they are aware of the odours that will be present. In response to Council questions, Ms. Couwenberg advised that the water pressure is not always consistent so they are trying to solve that issue. If the building is located in the proposed location, then a washroom and hand washing station is available for the chicken catchers and it would not be efficient to move it farther away. She also confirmed that they have discussed the proposal with the neighbours affected by the MDS setback reduction.

There was no one in attendance that wished to speak in support of or against the application.
