Mr. Bill Dietrich, Engineer, addressed the appeal received from Mr.'s Dwornikiewicz. He provided handouts to Council explaining the process for determining drainage assessments, as they relate to: benefit assessments, outlet, special benefits and road crossings. He explained how the assessment is calculated based on land located within the watershed area, land usage, location on the drain, area and specifically how it relates to the comparator provided by the appellant.

Mr. Chris Dwornikiewicz advised that he spoke Mr. Dietrich regarding the appeal that was provided with information on the calculations for assessments. Mr. Dwornikiewicz explained his concerns making comparisons to the neighbouring property, explaining the diagrams he submitted and questioning the elevations, land area, entry point of drain and catchment area, further commenting that he felt the DaCosta farm was benefitting more and should be paying more for this project.

In response to Council questions, Mr. Dietrich explained that over 50% of parcel 3 drains into the Beck Drain downstream and that the appellants entire property drains into the upper regions of the Treffry Drain. There was Council discussion with respect to the proposed drainage works and assessment explanation.

Details of Proposed Amendment: To rezone the subject property from 'Limited Agricultural Zone (A1)' to 'Special Limited Agricultural Zone (A1-sp)' to permit the establishment of a second single detached dwelling, for a total of two single detached dwellings on the subject lands.

Mr. Zulfigar, owner, was in attendance representing the application.

Ms. St. Clair, Senior Development Planner, outlined the application as contained within Report CP 2023-115. She advised that the applicant is proposing the construction of a second single detached dwelling on the property to the west of the existing structure and would share the existing driveway. Ms. St. Clair referred to the recently adopted policies by Oxford County related to accessory residential units explaining that the existing dwelling would be considered the ARU upon completion due to the large size of the proposed structure. She advised that there was one call from a neighbouring property owner, however, no comments or concerns were received.

Mr. Zulfiqar, owner, explained that he and four brothers moved to Norwich Township in 2020 and that he hopes to build a home for his new wife and make Norwich home.

Ms. Lillian Povoledo of 545885 Pattullo Avenue inquired about a municipal drain in the area and the property severance process.

There was no one else in attendance that wished to speak in favour of or against the application.
