6.2.1 Consideration of Engineers Report

Re: Haight Municipal Drain Improvement Report DR 2025-22

Mr. Chris Thompson, EIT, and Mr. Paul MacIntyre, P.Eng., R. J. Burnside and Associates Limited, provided an overview of the existing condition of the drain and the scope of the improvement which proposes to have a new 1 ½ inch design coefficient drainage system run parallel to the existing drain, which would be abandoned upon completion of the works. The improvement and other associated works are estimated to cost \$581,620.00 for construction and engineering.

6.2.2 Consideration of Engineers Report

Re: Manson Municipal Drain 1997 "J. & W. Ryksen" – Minor Improvement Section 78(5) Report Report DR 2025-23

Mr. Curtis MacIntyre, P.Eng., K. Smart Associates Ltd., advised that the report was prepared under Section 78(5) of the Drainage Act and provided an overview of the new expedited minor improvement process. He advised that the proposed works will relocate a section of the drain to facilitate the construction of a house. Mr. MacIntyre further advised that the proposal meets the requirements for a minor improvement and that costs for the project, approximately \$27,500.00, including engineering fees, will be covered solely by the property owner.

In response to questions from Council, Mr. MacIntyre explained that the proposed drain improvement's capacity must match the current capacity as one of the seven criteria for a minor improvement under the Drainage Act. Any additional improvements in regards to capacity or upgrades to the drain on neighbouring properties would be an improvement under Section 78(1). Mr. MacIntyre further advised that the property owner was also the property owner upstream from the subject property and was satisfied with the current performance of the drain.

Details of Proposed Amendment: To rezone the rear portion of lot to be severed from a recently approved consent application (B24-77-3) from 'General Agriculture Zone (A2)' to 'Residential Type 1 (R1)' to facilitate the creation of a residential infill lot in the Village of Springford. The effect of the proposed rezoning will be to fulfill a condition of the above noted consent application. The applicants are proposing to construct a single detached dwelling on subject lands.

Mr. Jake Dev and Ms. Dori Dev, applicants, were in attendance representing the application.

Ms. Amy Hartley, Development Planner, provided an overview of the application as contained within Report CP 2025-168. She advised that the applicant is requesting site specific zoning to facilitate the severance of a residential infill lot. She further explained that the severance included a minor variance to reflect a reduced lot area and lot frontage for the lot to be severed and a reduced lot frontage for the lot to be retained. Therefore, the zoning application will not contain any site-specific provisions as a result.

In response to questions from Council, Ms. Hartley explained that additional drawings are required from the applicant to produce the By-Law Schedules, which will be before Council at a future meeting. She also advised that the existing pole barn will need to be removed as a condition of the severance and that an 8-meter-wide frontage is being maintained for farm access.

Details of Proposed Amendment: Relief From: Section 5.21.1.7.3, Maximum Driveway Width (Residential Zones) – to permit an increased driveway coverage of 9.7 m (32 ft) where a maximum of 6 m (19.8 ft) of the front yard may be occupied by a driveway; and Section 5.21.1.7.4, Number of Driveways Permitted – to decrease the separation between two driveways from 9 m (29.5 ft) to 7.5 m (24.3 ft), to recognize a recently installed driveway on the west side of the subject lands.

Mr. Jerry Ryksen, applicant, was in attendance representing the application.

Ms. Amy Hartley, Development Planner, provided an overview of the application as contained within Report CP 2025-161. She advised that the applicant is requesting relief from the Zoning By-Law to permit an increased maximum driveway width and to decrease the separation between two driveways in a residential zone. She further explained the application was the result of a By-law Enforcement Notice of Violation with respect to installation of the second driveway without consultation with Public Works or submitting an application for an entrance permit.

Ms. Hartley advised that comments received from Public Works indicate the existing driveway was also widened and installation of the second driveway caused damage to a stormwater management pond fence owned by the Township. She further commented that a letter of concern was received from a neighbour expressing concerns with: aesthetics, the future use of the laneway and setting a poor precedent. Staff members also expressed concern that this may set a dangerous precedent.

Mr. Ryksen explained that the second driveway was to provide parking for his son who previously lived in their basement, advising that he intends to apply for an ARU and hoped the driveway could remain for a future occupant. He also advised that the drainage had not changed on the property as the grade had not been altered by the installation of the second driveway.

In response to questions from the Committee, Ms. Hartley explained that the entire second driveway is recommended to be removed.

There was no one else in attendance that wished to speak in support of or in opposition to the application.
