The Special Meeting of the Council of the Township of Norwich was held in the Council Chambers, Norwich, commencing at 6:00 p.m. with Mayor Palmer presiding.

There was Council discussion regarding pursuing an Official Plan amendment to support the facilitation of future cross boundary servicing to benefit area residents, the

potential costs, process and timelines associated with an Official Plan amendment, the City of Woodstock requiring the realignment of Pattullo Avenue to facilitate development of industrial lands acquired in the 2017 boundary adjustment, the benefits of tax revenues from the development of those lands and potential impacts of pushing the boundary adjustment implementation to January 1, 2026. There was additional Council discussion with respect to possible resident need for cross-border servicing in the event of septic or well failure.

In response to questions from Council, Ms. Robinson explained that cross boundary servicing violates the Official Plan and the Provincial Planning Statement, so the City of Woodstock is unable to support that aspect of the proposal from the Township of Norwich. She further explained that the province does support cross boundary servicing for drinking water where a safety need is demonstrated, which is why the properties on Greenly Line have access to water.

Ms. Armstrong commented that there are rare circumstances where services have gone across boundaries in extenuating circumstances. It is a user-pay system with additional service fees paid by those with access to those services, not the general tax base. Ms. Armstrong further recommended that Council direct staff to provide an additional report to review the potential process and costs of pursuing an Official Plan amendment if that was Council's wish.

In response to Council questions, Staff explained that the Township does currently receive tax revenue from the lands involved in the previous boundary adjustment, however due to the inability of the City to further develop those lands without the road realignment, there is currently no potential for any of the mutual prosperity payments. If the boundary adjustment is not implemented until the following year that will further delay development potential. Ms. Robinson recommended that Council provide direction for staff to continue to pursue the additional public consultation regarding the Minimalist Approach - Option 1.

And further that staff present public input received as a result of the Public Consultation to Council at the September 24, 2024 meeting to allow consideration of final approval.
