## Message from the Mayor

The Township of Norwich is committed to promoting a barrier-free Township for employees, citizens and all who live, work, visit and invest in Norwich.

The municipality has made many improvements to the parks, facilities and website since the implementation of the Ontarians with Disabilities Act in 2001. This multi-year report created in compliance with the Accessibility for Ontarians with Disabilities Act 2005 (AODA) outlines new initiatives and illustrates past achievements.

Although 2020 was a challenging year for all of us and there was much uncertainty, changes and challenges associated with the COVID-19 Pandemic, the Township of Norwich continued to work through some of the identified goals to enhance accessibility throughout the municipality.

The following are some of the completed projects: installation of sidewalk curb cuts at the intersections of: Carmen and Pitcher Street, Stover and South Street, South Court and Stover Street, Brock Street and corners at Stover Street and North Street.

Some of the goals identified for 2021 include: accessible features at a new Southwest Park in Norwich, Springford Picnic Shelter and paved pathways at the Burgessville Park.

We invite comments and encourage residents and businesses to make a commitment to accessibility also.

## **Message from the Accessibility Advisory Committee**

Members of the Accessibility Advisory Committee are committed to improving accessibility within the Township of Norwich for all of its residents and visitors. We will work with Council to identify areas that need improvement or remedial work to ensure safe and easy accessibility through the Township.



#### **Introduction & Statement of Commitment**

The Township of Norwich is located in the southeast corner of Oxford County in the heart of Southwestern Ontario. The population is approximately 11,001 (2016 Census Data). While being primarily agricultural lands, the township has several villages and hamlets. These are as follows: Norwich, Otterville, Burgessville, Springford, Oxford Centre, Curries, Hawtrey, Holbrook, Eastwood, Milldale and Cornell.

The Township of Norwich is committed to promoting a barrier-free Township for employees, citizens and all who live, work, visit, and invest in Norwich. This accessibility plan outlines the steps that will be taken to meet the requirements under the Accessibility for Ontarians with Disability Act and to improve opportunities for people with disabilities. The contents of this multi-year accessibility plan were developed in consultation with the accessibility advisory committee and employees.

## **Guiding Legislation**

#### Ontarians with Disability Act, S.O. 2001, C.32

The Province enacted the *Ontarians with Disabilities Act* in 2001. It imposes obligations on ministries, municipalities, hospitals, school boards, colleges, universities and public transportation organizations to develop annual accessibility plans. These plans must make policies, practices, programs, services and buildings more accessible to people with disabilities, and must be made available to the public.

#### Accessibility for Ontarians with Disabilities Act S.O. 2005 C.11

In 2005 the Province enacted the Accessibility for Ontarians with Disabilities Act (AODA), which imposes obligations on the Province and Municipalities concerning accessibility issues. The purpose of the Accessibility for Ontarians with Disabilities Act is to make Ontario a better Province by creating a society that is open and accessible to all. The Bill not only sets long-term goals for both the private and public sectors to make Ontario barrier-free by the year 2025, but also sets short and medium goals to ensure steady progress is made.

#### **Customer Service – Ontario Regulation 429/07**

The Accessibility Standards for Customer Service came into effect on January 1, 2008. Public sector organizations designated within the standard were required to be in compliance by January 1, 2010. The Township of Norwich is currently in compliance and continues to fulfill ongoing obligations under this standard.

### Integrated Accessibility Standards – Ontario Regulation 191/11

The Integrated Accessibility Standard came into effect on July 1, 2011. This regulation encompasses: Information and Communication, Employment, Transportation and the Design of Public Spaces (Built Environment). By integrating these standards, it harmonizes common requirements. The requirements of this standard will be phased in from 2011 to 2021. Components of these requirements are: policies, multi-year



accessibility plans, training employees, website accessibility, accessible emergency and public safety information, accessible recruitment policies, workplace emergency information and meeting requirements when constructing, maintaining or redeveloping various elements of public spaces.

#### **Built Environment**

Ontario's Building Code has been amended to include enhancements to accessibility in buildings. As of January 1, 2015, new construction and renovations will be subject to updated OBC accessibility requirements.

#### **Barrier Identification**

**Attitudinal** barriers may result in people with disabilities being treated differently than people without disabilities.

**Informational and communication** barriers arise when a person with a disability cannot easily receive and/or understand information that is available to others.

**Technological** barriers occur when technology or the way it is used does not meet the needs of people with disabilities.

**Systemic** barriers in policies, practices and procedures and result in people with disabilities being treated differently than others or sometimes excluded altogether.

**Physical and architectural** barriers in the environment and prevent access for people with disabilities.

#### **Accessibility Advisory Committee (AAC)**

Council approved Report C-A 2003-06 establishing an Accessibility Advisory Committee on February 11, 2003, and adopted the attached Terms of Reference. AAC meeting minutes are available through Council agendas. The Terms of Reference were amended by Resolution #14, November 11, 2008. The Committee's responsibilities range from providing a forum for persons with disabilities to raise issues and concerns, providing advice and guidance to Norwich Township Council on matters related to policies, practices and programs in the Township. A detailed Terms of Reference for the Accessibility Advisory Committee is available on the Township website.



### **Accessibility Partnerships**

Oxford County is comprised of three city/towns and five rural townships. There are four Accessibility Advisory Committee's within Oxford County and each one reports to their respective Municipal Councils on a variety of accessibility matters.

During 2015 the Oxford County AAC started hosting semi-annual accessibility meetings which include representation from all AAC's and staff from all Oxford municipalities. These events have speakers, presentations and members discuss accomplishments and challenges.

During 2017 representatives from Norwich Township have been working with the Oxford County AAC and some Oxford County staff to identify accessible features within our Parks. The information, photos and video will be incorporated into a website to ensure the public is aware of what each play area has to offer.

#### Feedback & Contact Information

The Township of Norwich has made significant progress in adopting practices that ensure accessibility is at the forefront of planning development of practices. This is accomplished through improvements to by-laws, policies, work procedures, facilities, parks, services and programs.

Members of the public are encouraged to make comments on the Township of Norwich Multi-year Accessibility Plan and any accessibility issues. There are a number of ways you can contact the municipality to express your accessibility related comments. A feedback form is also available on our website or by request.

#### **SCHEDULE B**

#### **Achievements to Date**

The Township of Norwich has been actively developing innovative approaches to addressing accessibility issues and is proud to report on the removal of current barriers and prevention of future barriers for people with disabilities and our maturing population.

The Township of Norwich is proud to report the following accomplishments:

#### **2020**



Completion of Sidewalk Needs Study which will identify problem areas and provide a schedule for future maintenance and replacement.

Completion of Provincial AODA Compliance Audit

Installation of curb cuts at several intersections within the Village of Norwich. (Stover St. & South St., South Court St & Stover St., Brock St. & Carman St. and Stover St. & North St.)

Reconstructed slope of sidewalk at laneway entrance between Shoppers Drug Mart and Circle K Convenience Store.

#### 2019

Downtown Norwich Parking Lot located behind Main Street businesses, was reconstructed and paved. Lot includes two accessible parking spaces located near the Village Walkway for easy access to downtown.

Installation of curb cuts at numerous intersections within the Village of Norwich.

Sidewalk replacement completed on sections of South Court Street East and Cook Street in the Village of Norwich.

New Township of Norwich website created.



#### 2018





Downtown Norwich sidewalk along the south side of Main Street from Pitcher Street around the corner at Stover street to Front Street. Sidewalk was rebuilt and wherever possible the sidewalk was the sloped to the business entrance to allow for accessible entrance instead of a step. Tactile strips were installed at intersections.

The 2018 Municipal Election included steps to ensure accessibility needs were met. Report CAO 2019-04, presented to Council on January 10, 2019 outlined considerations taken to enhance accessibility for the Election.

Renovation of the Springford Hall included creation of a new accessible washroom and automated sliding entrance doors, as well as paved parking with accessible parking spaces and

improved lighting.

Installation of curb cuts at several locations on well-travelled sidewalks in the Village of Norwich were completed. Locations were identified during the October 2017 Sidewalk inspection.

Parking lot at the Oxford Centre Hall was repaved.

New Norwich Soccer Park was created with accessible walking paths constructed around all of the new fields.



#### 2017

Installation of paved pathways in Polden Park and Dillon Park in Norwich.



Installation of new bleachers which include accessible seating areas and additional paved pathways in the Otterville Park.

Norwich Community Centre -Installation of a new accessible water fountain

Paxton Street in Otterville – new sidewalks and curb cuts installed

North Street Parking Lot in Otterville – sidewalk installed from parking lot to Main Street

Springford Hall - Tender accepted for installation of a new asphalt parking lot with accessible parking spaces as per building code and installation of cement sidewalks with appropriate curb cuts and improved lighting for enhanced accessibility.


Council approved purchase of a sound system to enable those in attendance at Council meetings to hear presentations more easily.

Continued implementation and management of accessibility policies and training

Installation of new playground equipment at Dillon Park which incorporates accessible features and surface

#### 2015

Curries Park - paved walkway to pavilion and playground

Municipal Administration Building – new construction which includes many accessible features and Council Chambers

Oxford Centre Hall – new accessible sliding doors installed

Sidewalk improvements including: curb cuts on Main Street and Pitcher Streets in Norwich and improved sidewalks from post office to park in Burgessville

Norwich Community Centre – new accessible sliding doors installed

Otterville Park – replaced existing damaged paths with wider asphalt pathways, installed a small splash pad and conversion of pea gravel surface under playground equipment to an accessible surface

Amended Procurement Policy to include accessibility considerations

#### 2014

Curries Picnic Pavilion built, includes an accessible picnic table

New curb cuts installed during construction on North Street and Albert Street in Norwich and on Dover Street in Otterville

Execution of an accessible municipal election

New Norwich.ca website that meets accessibility criteria



Stairs installed at the Otterville pool for increased ease in entering the pool

#### 2012 / 2013

New playground equipment installed at Curries Park which includes some accessible features

Pioneer Room renovation which includes: ramped and automated entrance, accessible washrooms and installation of friction resistant flooring at Pioneer Hall

New automated sliding doors installed at the Nor-Del Arena

Installation of accessible curb cuts at Pitcher and Tidey Streets



A multi-year Accessibility Plan was approved by Council at their meeting on December 10, 2013

Installed accessibility awareness signs on Pitcher and Palmer Streets in the Village of Norwich

Employment Standards Policy and Information and Communication Policy adopted by Council at their meeting November 26, 2013 followed by training sessions

#### 2011

Accessible counters were installed at the Norwich Community Centre Kitchenette and the Oxford Centre Hall bar counter area.

A new ramped entrance was installed at the Otterville Pool house

New bleachers were installed in Springford park with back rests and hand railings.

An accessible picnic table was located at the Harold Bishop Park

New playground equipment was installed at the Oxford Centre Park which included some accessible features.



#### <u>2010</u>

Harold Bishop Park – installed a paved accessible pathway around the barrier free play structure, enhancing accessibility

Norwich Arena – re-painted stair nosings for better visibility

Harold Bishop Park – accessible picnic tables

Barrier free Porta-Potties were used at several locations throughout the Township (ball diamonds and passive parks)

#### 2009

By-law 40-2009 was passed amending By-law 06-2005. Changes include a clause advising that all service animals must be registered within the township, but are exempt from paying license fees.

A portion of the Norwich Community Centre Bar and the Arena Snack Bar counter tops have been lowered to enable greater accessibility for everyone.

An accessible ramped viewing platform was constructed in the cold area of the Norwich Arena.

Stair nosings at all facilities have been painted for better visibility.



An Accessible Customer Service Policy was adopted by Council via resolution #37 passed October 13, 2009. This policy addresses all information as required under the AODA, Ontario Regulation 429/07 (Accessibility Standards for Customer Service)

Training course materials and procedures have been developed for staff, council, volunteers and third parties providing services on the townships behalf. Training will be completed prior to December 23, 2009.

#### 2008

In January 2008, the Otterville Library moved to a new location. The new location includes an accessible ramp, family washroom, better lighting and more space, which enables better mobility.



The font in the bi-annual tax flyer has been changed to Arial and enlarged to enable easier reading.

New playground equipment has been installed in the Springford Park, which includes an accessible surface and some accessible play features.

The ramp to the accessible exterior washroom in Oxford Centre has been corrected to comply with Ontario Building Code Standards.

The font size in the Community Resource & Leisure Guide has been increased to 12 for easier reading.

On September 9, 2008, Report RPF 2008-43, Norwich Community Centre re: Auditorium Washroom Renovations Tender Results was approved by Council and the tender awarded. The washroom project at the Norwich Auditorium was completed in November 2008. The retrofit includes an accessible stall that is family oriented in both the men and women's washrooms. These enlarged stalls include toilet, sink, handrails, mirror, paper towel dispensers and baby change table.

The Township of Norwich website has additional accessibility information available on it, as well as links to other informative sites.

On February 29, 2008 the Deputy Clerk attended an AMCTO workshop regarding the new Accessibility Standards for Customer Service, which must be complied with by January 1, 2010.

The footbath at the Otterville Pool has been filled in to eliminate steps and provide a level surface when entering the pool area.

Norwich Arena / Community Centre south parking lot has been re-lined to include six accessible parking spaces along the front of the building.

#### 2007

Report RPF-2007-23, Harold Bishop Park Playground Equipment re: Tender Results, was presented to Council at their meeting May 8, 2007. The evaluation of the Committee was based on play value, number of components, service and accessibility. The approval of the recommendation contained within this report represented the installation of the first accessible playground within the Township.



Report RPF 2007-24, Medical Centre re: Parking Lot Lighting Tender Results was presented to Council at their meeting May 8, 2007. This ensures improved lighting at the Dr. Russell M. Hall Family Medical Centre for individuals who suffer from a visual impairment and/or night blindness.

Report RPF 2007-44, Arena Door Hardware & Barrier Free Doors Tender Results, was presented to Council at their meeting August 14, 2007. The purpose of this project is to provide barrier free access to all entrances at the Norwich Arena and Community Centre.

With recommendations from the Accessibility Advisory Committee, a comprehensive plan was developed to make the Oxford Centre Hall an accessible facility. The renovation included the installation of an additional accessible parking space, a ramped entrance, automated entrance doors, accessible interior and exterior washrooms.

Approval was received for the new accessible playground at the Ducky Dennis Athletic Park in Burgessville. Installation commenced November 7, 2007.

In March the Chief Building Official and the Deputy-Clerk attended the Oxford County Builders Forum session on CMHC's Flexhousing Barrier Free Design.5+

In April the Director of Recreation, Parks and Facilities and the Deputy-Clerk attended an information session at KSL Design Inc. in Brantford regarding accessible playgrounds



### **2006**

The New Norwich Public Library was built to be completely accessible, according to the Facility Accessibility Design Standards adopted by the County of Oxford.

Engineered drawings have been made of the proposed washroom upgrades and ramped entry to the Oxford Centre Hall. These drawings were forwarded to the Trillium Foundation with a grant request.

Signage was placed in the Norwich Arena to mark the heated accessible viewing area.

#### 2005

Section A (5) of the 2004 MunAP (Municipal Accessibility Plan) addressed the fact that there was no official public input system to identify barriers and gaps in existing services / programs. There is now information posted on the website as well as the Municipal Office to address this issue.

On July 12, 2005 the Township of Norwich Council passed By-law 53-2005, being a By-law to Regulate Handicap Parking within the Township of Norwich. Signs have been posted at the locations identified in Schedule A.

Section H (1) of the 2004 MunAP, identifies many accessibility issues within municipally owned facilities. During the renovation of the Norwich Arena / Community Centre some of these issues were addressed:

- > Push button operator on main entrance doors to arena
- > Elevator to allow access to the second floor
- Expanded washrooms in arena lobby to include a barrier-free toilet in the Men's and Women's washrooms
- ➤ Installed barrier-free toilet in the Men's and Women's washroom in the Community Centre Lobby
- New washrooms provided at the north end of the Community Hall are barrier-free accessible

Prior to the renovation project some other items were addressed:

- > Stair nosings at the Norwich Arena were painted yellow for added visibility
- Previous Handicapped parking locations were moved closer to the Arena and Auditorium entrances
- Stair nosings and elevation changes were painted yellow for added visibility at the Otterville Pool – guard house and shower area

The Otterville Hall Advisory Committee includes a member of our Accessibility Advisory Committee.

Section J (1) of the 2004 MunAP, identified a lack of information on accessibility within the community as a whole. Report RPF-2005-15, 2005 Summer Experience Program – Student to Conduct Cultural Research, went before Council on April 12, 2005. This



position was responsible for conducting research into the arts, heritage and cultural sectors of the Township. While identifying the programs and services available, they were also assessed for accessibility.

#### 2004

Chief Building Official, Brian Reid attended an Accessibility Seminar while at the Ontario Building Officials Annual Meeting held in Etobicoke. He also returned with information for staff reference.

The Norwich Arena Steering Committee included a member of our Accessibility Advisory Committee.

\*\*Section J, Part 1 of the First Accessibility Plan relayed a lack of information on accessible restaurants and amenities in the community. In an effort to gather information the Accessibility Advisory Committee inserted a questionnaire into the Tax Bills mailed to Commercial properties in February. The intent of the Committee was to produce a pamphlet including this information, and also make it available on the website. Due to a very disappointing response (9/300) the project was not completed.

#### 2003

Treasury Report TR-2003-29 was presented to Council on Tuesday June 10, 2003, outlining the ten-year plus program to install new streetlights in the Township. (on-going improvements)

Public Works Report PW-03-15 outlining the Level of Service Standards was presented to Council on June 10, 2003. This report outlines sidewalk snow clearing and repair standards, as well as response times for non-functioning streetlights.

Recreation, Parks and Facilities Report RPF-2003-22 to develop a Norwich Arena / Community Centre Steering Committee includes a recommendation that a member of the Accessibility Advisory Committee be appointed to the Committee for accessibility input purposes.

Improvements to the 2003 Voting Stations:

North Norwich Public School utilized a ramp for accessibility to the facilities. Recreation, Parks and Facilities staff manufactured a portable ramp for access to the Oxford Centre Hall, this ramp can also be utilized for Public rentals.
