Ms. St. Clair outlined the application as contained within Report CP 2022-385. She advised that the application proposes to rezone lands to facilitate an industrial lot addition and fulfil a condition of consent. The applicant proposes to add lands containing a recently constructed warehouse to the adjacent industrial bakery facility lands to the immediate east. The merger will sever remaining farmlands, facilitating a minor boundary adjustment and not creating a new lot.
